Sealed bids for Exterior Cleaning / Sealing / Painting of the Kitty Hawk Elementary and Manteo Elementary School buildings located at Kitty Hawk and Manteo, North Carolina respectively, will be accepted by the Dare County Schools Facilities Director on **Wednesday, May 3, 2017** at the **Dare County Schools Administration Building** located on the campus at Nags Head Elementary School, **3020 Wrightsville Ave., Nags Head, North Carolina**. Single Prime, Firm Fixed Price bids for the work will be accepted until 2:00 PM local time. **Bid opening will begin at 2:01 PM on Wednesday, May 3, 2017.**

A **Pre-bid Conference** is scheduled for **Wednesday, April 19, 2017 at 3:00 PM** at the conference room at the Kitty Hawk Elementary School, 100 Veterans Drive, Kill Devil Hills, North Carolina.

A **Pre-bid Conference** is scheduled for **Thursday, April 20, 2017 at 3:00 PM** at the cafeteria of the Manteo Elementary School, 701 N. Hwy 64/264, Manteo, North Carolina.

A tour of the school sites will be conducted as a part of the conferences to allow attendees an opportunity to inspect existing conditions. Because of the need to fully understand the scope of work, all prospective bidders are required to attend the Pre-Bid Conferences.

The project sites are open and easily accessible to the public. However, the school sites are not available for bidder inspection while educational classes are being conducted. Visits by prospective bidders will be authorized only during non-classroom periods and only after coordination with the Dare County Schools Facilities Department.

Bid documents will be available on **April 6, 2017**. Bidders should obtain copies of bid documents by contacting Dare County Schools, Facilities Department at 252-480-8888 ext. 1913 or pickup at the Dare County Schools Administration Building at the address shown above.

The Dare County Board of Education, in accordance with its goals adopted for participation by minority businesses, encourages minority businesses to submit bids for this construction project.
